



PROCLAMATION DECLARING HUMBLE PRAYER AND PETITION TO GOVERNOR-GENERAL OF THE COMMONWEALTH OF AUSTRALIA

WHEREAS the undersigned a Citizen of Australia humbly relying on the blessing of Almighty God, say publicly to Governor-General of the Commonwealth of Australia to govern according to the clearly expressed WILL in accordance with my lawful obligation to keep The Queen and Her Majesty's Representative informed on any matter that comes before the Parliament or should come before the Parliament.

AND WHEREAS this Humble Prayer and Petition is a lawful document and within legal privilege directly ask Her Excellency Ms Quentin Bryce AC Governor-General of the Commonwealth of Australia to convey MY WILL to the Prime Minister of Australia, to both Houses of the Parliament, and to the Commonwealth Public.

BE it therefore enacted by legal privilege to declare in this Proclamation with Humble Prayer and Petition of MY WILL To Her Excellency Ms Quentin Bryce AC Governor-General of the Commonwealth of Australia Government House, CANBERRA, ACT. 2600

MAY IT PLEASE YOUR EXCELLENCY,

Commonwealth of Australia Constitution Act (The Constitution) is the fundamental law of Australia binding everybody including the Commonwealth Parliament and the Parliament of each State, and judicially described as 'the sovereignty of the Australian people' is also recognised by section 128 of the Constitution which provides that any change to the Constitution must be approved by the people of Australia that include any change to 'An Australian Common Market'<sup>1</sup> which was one of the main reasons for the movement by the Australian people towards federation.

The Constitution confer the Parliament (Chapter I), the Executive Government (Chapter II), and the Judicature (Chapter III), and that, the Parliament shall, subject to this Constitution, have power to make laws for the peace, order, and good Government of the Commonwealth, and by the fact that the Prime Minister and the other Government Ministers must be members of Parliament. This reflects the principle of responsible Government.

Our Royal guest The Emperor His Imperial Majesty QEUMARS Shahanshah of Iran Head of The Imperial by His Imperial Authority wishes to invite The Emperor and Empress of Japan and the world respective Heads of Monarchs to Australia for promoting peace, good order and prosperity. That, from 9 June 2009, The Emperor's message for Royal invitations broadcasted by Television Networks across Australia, and to this month the broadcasting downloaded via www.IranImperial.com.

Hereby, acknowledge the information at http://www.IranImperial.com/Economy.pdf that The Emperor's invitation is to manifest the gathering of Nations in Australia, and that, The Emperor and Empress of Japan are the principal integrity of the Japanese Nation. The Emperor's invitation would benefit An Australian Common Market.

NOW, THEREFORE, it is MY WILL and MY EXPRESS WILL that within twenty-eight days herein the Prime Minister Kevin Rudd take immediate action and without delay to ask from The Emperor QEUMARS to invite The Emperor and Empress of Japan and the world respective Heads of Monarchs for gathering of Nations in Australia.

Hereto, inform both Houses of the Parliament and the Prime Minister Kevin Rudd to take notice, no Government or authority or organization or legal practitioners or the head of the Government (the Prime Minister) or the principle decision-making body in the Government have any power or any jurisdiction whatsoever neither legally nor publicly or personally or individually to obstruct or to be prejudice or to scam or to override MY WILL.

Hereby, in accordance with Australian law and subject to The Emperor QEUMARS wish to invite Heads of Monarchs to Australia, I may engage an agent, prepare business plan, advertise and arrange insurance cover. Thereby, any injury to MY WILL, either by way of any acts or omissions or to cause any detriment of any kind to MY WILL, it shall be the consent and the agreement of the Prime Minister Kevin Rudd to take responsibility and to pay to the undersigned full liability which may arise over \$10 million or \$20 million or \$100 million, and pay to the undersigned for loss and damages, include loss of business opportunity.

YOUR EXCELLENCY, in accordance with my lawful obligation to keep you informed of MY WILL, upon any intimidation, prejudice or discrimination against MY WILL, thereby, pursuant to Royal Commissions Act 1902, I request from Your Excellency the Governor-General of the Commonwealth of Australia to issue Royal Commission to carry out a thorough and rigorous inquiry in regard with the peace, order, and good Government of the Commonwealth, include loss and damages to MY WILL.
